

Words from Robert Petit, Head of the Mechanism

The unexpected overthrow of the Assad regime in December 2024 marked a turning point for the Syrian people and for the IIIM.

From its establishment in 2016, the IIIM attempted to engage with the Syrian authorities without success. Since December 2024, the IIIM has conducted several missions to Syria and has been working tirelessly to engage with the caretaker authorities to secure approval to operate on the ground and to support the transitional justice process.

In 2024, the IIIM spared no effort in discharging its mandate. We responded to an increasing number of requests for assistance, we advanced work on our structural investigation and continued to work closely with our Syrian civil society partners. As you will see in this annual report, we were able to make significant progress in supporting justice efforts for Syria through universal jurisdiction cases. For the first time, we publicly released an analytical report and circulated it widely to contribute to ongoing justice and accountability efforts.


The IIM's achievements are all the more remarkable as we faced a difficult financial situation resulting in a reduced team facing increasing demands. Going forward, and with new opportunities arising from the possibility to operate in Syria, the IIIM will increasingly rely on voluntary contributions to complement our regular budget.

I look forward to your support to be prepared to support Syrian initiatives to bring perpetrators of atrocity crimes to justice.















IIIM in the media



UN calls for Syrian-led justice, accountability in political transition



GENEVA, Dec 17 (KUNA) – The Head of UN International, Impartial and Independent Mechanism (IIIM) Robert Tuesday the importance of a Syrian-log Justice and accountability as essential components of the political transit Pett said, in a press statement in Geneva, that the Syrian people have shown a clear commitment to justice, ma accountability an integral part of any comprehensive political solution. Pett revealed that IIIM has collected 283 Terabytes of data related to crimes committed in Syria since 2011 with supporting current and future judicial investigations.

Financials

The IIIM is primarily funded through assessed contributions from Member States to the UN regular budget. This funding is complemented by voluntary contributions (extrabudgetary funding) from donors, the majority of which are Member States.


In 2024, the IIIM's total expenditure was USD 20,823,600. Of this total, 67 per cent was funded by the United Nations regular budget and 33 per cent by voluntary contributions.

The UN regular budget should finance all activities mandated by the General Assembly. The regular budget allocation, however, has maintained constant since 2020 and therefore does not keep pace with the growth in the demand for IIIM's services.

For the third year in a row, in 2024 the IIIM faced a level of demand for its services which exceeded its annual income.

The IIIM is grateful to its donors, including those who provided voluntary contributions in 2024.

INCOME & EXPENDITURE (regular budget + extrabudgetary)




In 2024, the funds made available to the Mechanism were insufficient to enable it to respond to the increasing number of demands from competent jurisdictions. For the first time, the Mechanism reached the symbolic figure of 100 requests for assistance received during the year. However, the insufficient level of funding compelled the Mechanism to terminate 13 posts during the course of 2024.


As evidenced by the charts of previous pages, the increase in demands for IIIM support by competent jurisdictions has resulted in the production of more analytical products, and more work responding to the

increasing number of requests while many requests from previous years require continued work. As in previous years, the income of the Mechanism in 2024 did not meet requirements, which compelled the Mechanism to decline requests for assistance or reduce the support it was able to provide. In 2024, the funding deficit continued and total income only exceeded total expenditures due to extrabudgetary funds received in advance, for 2025. The funding gap for 2025 will largely depend on whether or not a proposed presence in Syria will be funded through the regular budget.

REQUESTS FOR ASSISTANCE





Impact of funding gap

IN 2024, DUE TO THE FUNDING DEFECIT, THE MECHANISM:

- >> Had to decline requests for analytical products in 14 instances from 7 competent jurisdictions
- >> Had to **limit the scope of searches** in the Central Repository for approximately 35% of the requests submitted
- Had to decline requests for 5 witness interviews
- >> The average **time required to respond to requests has increased**, with non-urgent requests being handled on average 8 to 10 months after submission
- >> No longer proactively offers support through open-source investigations in Arabic and Russian
- >> Limited engagement with witnesses potentially at risk due to insufficient follow-up options
- Significant **decrease of collections** solely for preservation purposes
- >> Closure of one line of inquiry
